**SPECIAL CONDITION OF CONTRACT**

**1. DEFINITIONS AND INTERPRETATION:**

In this Tender Document, as hereinafter defined, the following words and expressions shall have the meaning as under:

- a) "BBJ" shall mean The Braithwaite Burn and Jessop Construction Company Limited having its Head Office at 27, Rajendra Nath Mukherjee Road, Kolkata- 700001.
- b) The "TENDER" shall mean the proposal submitted by the Tenderer/Bidder in response to BBJ's Notice of Invitation to this Tender Document.
- c) The "ORDER" shall mean a written Purchase Order issued by BBJ.
- d) The "SUPPLIER" / "MANUFACTURER" shall mean the person, firm or Company (hereinafter called Tenderer) whose Tender has been accepted by BBJ.
- e) S.W. Railway means "South Western Railway" and/or their Authorized representatives.

**2. SCOPE OF SUPPLY:** As per BILL OF QUANTITY (BOQ)

**3. VARIATION IN QUANTITIES:** Variation will be within  $\pm$  25% of the ordered quantity.

**4. INSPECTION & TESTING:**

Manufacturer's Test Certificate & By BBJ/ S.W. Railway/ S.W. Rly's Approved Agency.

**The following aspects may be noted in this regard:**

- a) In addition to above, random samples of the Bolts shall be collected by BBJ/ S.W. Railway/ S.W. Rly's Approved Agency for Third Party Testing by NABL accredited Laboratory at any stage to confirm the fulfilment of the acceptance criteria.
- b) In case of rejection of Bolts at any stage by any of the above inspection agencies, the defective lot/lots of Bolts must be replaced by the supplier by a fresh lot for further inspection and testing by the inspection agency nominated by BBJ within a reasonable time without any extra cost to BBJ. Inspection and test report clearing this replacement lot with acceptable test results as per relevant IS codes and confirming all the requirements must be submitted before dispatch. Inspection certificate shall not absolve the supplier from replenishing defective Bolts at any stage.
- c) Inspection Charges will be reimbursed by BBJ at actual on submission of all the relevant documentary evidences along with bill against delivery, subject to acceptance of the lot by the inspection agency.

**5. FIRM PRICE:**

Rate shall remain firm and shall not attract escalation due to any reason such as Steel price hike whatsoever in pursuance of this contract during the delivery period or up to the extended delivery period as the case may be from the date of purchase order. No escalation or any variation in prices is payable to the supplier on account of any increase or modification in the tax structure or introduction/modification of existing levy structure.

**6. TAXES & DUTIES:**

The contractor shall be exclusively responsible for payment of all Taxes, Royalties etc. (except Goods and Service Tax) that may be levied from time to time according to the Laws & regulation now in force & also hereafter to be imposed, increased or modified from time to time. **7. GOODS AND SERVICE TAX (GST):**

- a) The quoted price shall be **exclusive of Goods and Service Tax**. The GST as legally leviable & payable by the bidder under the provisions of applicable law/act shall be paid extra by BBJ as per supplier's bill. **Bidder shall quote their rate after considering the input tax credit on their inputted materials and services.**

- c) At present GST-TDS is applicable. Deduction of GST-TDS at source would be enforced from the running bills at the rates prescribed. **12. DELIVERY PERIOD EXTENSION**

If there is delay for reasons not attributable to the supplier/contractor, BBJ upon receipt of written request justifying such delay from the Supplier may extend the Delivery period as suitable and fit reasonable to BBJ. No extra claim of supplier will be entertained in such cases of time extension being granted.

**13. SECURITY DEPOSIT:**

For successful bidder, Earnest Money Deposit (EMD) will be converted into security deposit and will be retained by BBJ till successfully completion of supply of HSFG Bolts, Nuts & Washer without any interest. On receipt of formal application from the supplier for releasing of EMD, BBJ will release the amount after completion of entire supply.

**14. GUARANTEE:**

**15. SUBLETTING OF WORK**

No part of our Purchase Order nor any share or interest thereof shall, in any manner, be transferred, assigned or sublet by the successful bidder/supplier directly or indirectly to any person or firm or company, whatsoever the name, without the prior consent in writing of BBJ and IRCON.

**16. LIQUIDATED DAMAGE:**

If the Supplier fails to supply the quantity within stipulated delivery period, as mentioned in the order, 0.5% (zero point five percent) of order value will be deducted from bill/invoice for per week of delay or part thereof, subject to a maximum of 5% (five percent) of the total order value.

**17. TERMINATION OF CONTRACT:**

If the supplier/party failure to complete the total work/ supply/ service as per requirement and within the stipulated completion period, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency/ agencies by issuing first seven days and then 48 hours' notice. On account of termination due to noncompliance of contractual obligations, EMD/ Security Deposit shall be forfeited. Additionally, supplier's pending bill, if any, shall also be forfeited to recover the additional cost.

**18. ARBITRATION:**

In the case of dispute arising between the Employer and Contractor related to any matter arising out of or connected with this Contract, such dispute shall be referred to the Arbitral Tribunal consisting of 03 (three) arbitrators, one each to be appointed by the Employer and Contractor, the third arbitrator shall be chosen by the two arbitrators so appointed by the parties and shall act as Presiding Arbitrator. In case of failure of the two arbitrators, appointed by the parties to reach upon a consensus within a period of 30 days from the appointment of the arbitrators, upon the request of either or both parties, the presiding arbitrator shall be appointed by the President, Institution of Permanent Way Engineers (India), New Delhi. If one of the parties fails to appoint its arbitrators in pursuance of para (1) above, within 60 days after receipt of the notice of the appointment of its arbitrators by the other party, the Secretary General of the Permanent Court of Arbitration, The Hague or The President, Institution of Permanent Way Engineers, India, New Delhi shall appoint the Arbitrator. A certified copy of the Secretary General's order or The President, Institution of Permanent Way Engineers, India, New Delhi order, as the case may be, making such an appointment shall be furnished to both the parties.

Arbitration proceedings shall be held at Kolkata, India, and the language of the arbitration proceedings and that of all documents and communications between the parties shall be English.

The decision of the majority of arbitrator shall be final and binding upon both parties. The expenses of the arbitrators as determined by the arbitrators shall be shared equally by the Employer and the contractor. However, the expenses incurred by each party in connection with the preparation, presentation, etc., of its case prior to, during and after the arbitration proceedings shall be borne by each party itself.

All arbitration awards shall be in writing and shall state the reasons for the award.

**19. JURISDICTION OF COURT:**

The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.

- g) All Bolts, Nuts & Washers must have Manufacturer's Test Certificate in addition three sets of random sample consisting of 1 no Hex. HD. Bolt + Hex. HD. Nut + Plain washer/ Taper washer from each lot to be sent to reputed independent NABL accredited Laboratory.
- h) All Bolt, Nuts & Washer should have coating of Zinc phosphate as per IS 1367 (PART-XII).
- i) Bolts length with respect to Grip & Thread length details to be verified by the party prior to approval of manufacturing.
- j) Dimensional details to be provided by the party for prior approval before manufacture.
