Notwithstanding the sub-division of the documents into the separate section, every part of each shall be deemed to be supplementary to and complementary to every other part.
02.	<u>LANGUAGE</u> Bids and all accompanying document shall be in English. In case any accompanying documents are in other language, it shall be accompanied by an English translation. The English version shall prevail in matter of interpretation.
03.	<u>SUBMISSION OF TENDER</u>
a)	The Tender shall be signed by the person legally authorised to enter into commitment on behalf of the Tenderer.
b)	All the pages of the tender document to be signed with Company's seal by the Tenderer. The rates in the appropriate space in the BOQ-1 should be properly filled, both in figures and words. No overwriting, using of correction fluid will be allowed. Any correction will be done by scoring out the incorrect entry and inserting the new entry in a legible manner. Both the correction and new entry to be signed and sealed with Company's seal. In the event of any difference between figure & words of the quoted rates, the rate in word shall be considered for evaluating the tender.
c)	The tender is to be submitted in a sealed cover and superscribed with Tender Reference, Due Date, marked for the Deputy General Manager(Project-V), BHARAT BHARI UDYOG NIGAM LIMITED 27, R.N.Mukherjee Road, Kolkata-700 001 (W.B.).

SPECIAL CONDITION OF CONTRACT

1. DEFINITIONS AND INTERPRETATION:

In this Tender Document, as hereinafter defined, the following words and expressions shall have the meaning as under :

- a) "**BBUNL**" shall mean The BHARAT BHARI UDYOG NIGAM LIMITED having its corporate office at 27, R. N. Mukherjee Road, Kolkata - 700 001.
- b) The "**TENDER**" shall mean the proposal submitted by the Tenderer/ Bidder in response to BBUNL's Notice of Invitation to this Tender Document.
- c) The "**ORDER**" shall mean a written Work Order issued by BBUNL.
- d) The "**PARTY**" shall mean the person, firm or Company (hereinafter called Tenderer) whose Tender has been accepted by BBUNL.

2. SCOPE OF WORK:

- a) 50 Ton capacity Tyre mounted Crane on hire basis for 01(one) month to be deployed at Chaibasa Site, Jharkhand for loading, unloading, handling and assembly of Bridge components and other steel items. Herein after to be mentioned as 'assembly crane'.
- b) Hiring Period of the above Crane will be for a period of one month. However, the hiring period may increase / decrease as per decision of Site-Incharge / Site-Engineer.
- c) 125 Ton capacity Tyre mounted Crane to be deployed at Chaibasa Site, Jharkhand on per Girder erection rate basis for erection of Girders on Bed block Herein after to be mentioned as 'erection crane'.
- d) The erection crane shall be deployed for erection of girders (6 nos.) based on the availability of Power Block from Railway. Since, the block from Railway is not under our control, hence, deployment duration may vary according to the availability of traffic and power block from Railway. The scope of erection crane also includes the assembly, shifting of girders before erection. No claim shall be accepted on this account.
- e) **Duty hours-** 12 hours shift i.e 8 AM to 9 PM , lunch break up 12 PM to 1 PM. However, the Site Incharge/Site Engineer of BBUNL Chaibasa Site, Chattisgarh may change the duty hours as per need. Duty hours of the crane to be noted in the Time Sheet/Log Book duly signed by Site Incharge/Site Engineer, BBUNL Chaibasa Site, Jharkhand or his nominated representative.
- f) Skilled Crane operator with valid documents/Certificates to be provided for the above Crane.
- g) All necessary safety devices for the Crane and the Crane operator to be provided by the party.
- h) All necessary valid documents in connection with the above Crane to be provided during operation of the Crane at site by the party.
- i) **Fuel & Lubricant** – For running the Cranes, supply of fuel and lubricant will be under scope of Crane Supplier.

- j) **Breakdown** – In case of any breakdown during the working hours, the hours lost during repairing of the Crane will be deducted from the bill as per time sheet /Log sheet.
- k) Maintenance of repairing of the Crane to be done by the party at their risk and cost. Any cost toward accident/damage/lost during operation/ hiring period of the above Crane to be born by the party. BBJ will not be responsible for any contractual/Legal obligation in this matter.
- l) **Accommodation** – Accommodation of Crane operator and helpers will be provided by BBUNL (free of charge).

3. FIRM PRICE:

Your rate shall remain firm and shall not attract escalation due to any reason such as diesel price hike whatsoever in pursuance of this contract for a period of six months from the date of order.

4. PAYMENT TERMS:

- i. Mobilisation Charges @ 10% of quoted rate will be paid after reaching of both the cranes at site in working condition. The Crane supplier is to assure the erection of girders on bed block before disbursement of Mobilisation charges by BBUNL
- ii. For assembly Crane, balance 90% will be paid within 30 days after submission of clear bill.
- iii. For Erection crane, 45% payment will be released after erection of 3 (three) girders on Bed Block, balance 45% payment will be released after erection of balance 3 (three) girders on Bed Block with intermediate cross girders.

5. TERMINATION OF CONTRACT:

In case of failure to discharge the duties as per our requirement, BBUNL reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency /agencies. Extra cost incurred for the above shall be recovered from the contractor's bill and Security Deposit.

6. JURISDICTION OF COURT:

The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.
