 4. **Delivery Period & Delivery Place** :- Within 30th June, 2016 in phases or as per time to time requirement by our site. Delivery to be made at BBJ Kalaichandi Khal, Paschim Medinipur.
 5. **Payment** :- Within 30 days from the date of delivery and submission of bill with receipted challan.
 6. **Liquidated Damage** :- If you fail to complete supply as per our order within stipulated period, 0.5% of order value will be deducted from your bill for per week of delay subject to maximum of 5% of order value.
 7. **Termination of Contract**:- If the supplier failure to complete the total work/supply/service as per requirement and within the stipulated completion period, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency/agencies by issuing first seven days and then 48 hours notice.
