2. **Rate** :- Your quoted rate should be inclusive of all taxes and duties and delivery charges up to our Heavy Plant Yard, Kolkata. Entry Tax, if any, will be borne by BBJ.

3. **Validity of Rate** : Your quoted rate should be valid and firm for a period of 3(three) months from the date of opening of your offer.

4. **Delivery Place**:- At BBJ Heavy Plant Yard, P-82 Taratala Road, Garden Reach, Kolkata-70 024 alongwith Manufacturr's Test Certificate.

5. **Delivery Period**: - Within 30 days from the date of LOI/ORDER, whichever, is earlier.

6. **Earnest Money Deposit** :- An amount of **Rs.5,000.00**(Rupees five thousand only) in the form of **Demand Draft/Pay Order/Banker's Cheque** in favour of **"The Braithwaite Burn And Jessop Construction Company Limited"** payable at **Kolkata**.

  - (d). For existing supplier(s), the EMD amount may be adjusted from their passed bill(s) amount subject to submission of their written declaration with their offer in connection with adjustment of their EMD.
7. **Payment** :- Within 30 days from the date of delivery and submission of bill with receipted challan along with Manufacturer's Test Certificate.
  8. **Liquidated Damage** :- If you fail to complete supply as per our order within stipulated period/time, 0.5% of order value will be deducted from your bill for per week of delay subject to maximum of 5% of order value.
  9. **Termination of Contract**:- If the supplier failure to complete the total work/supply/service as per requirement and within the stipulated completion period, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency/agencies by issuing first seven days and then 48 hours notice. Additional cost if incurred shall be recovered from the supplier's bill.
  10. **JURISDICTION OF COURT**:  
The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes,if any, arising out of this agreement between the parties.
