**SPECIAL CONDITION OF CONTRACT****SCC-1****1.0 Eligibility Criteria:**

- 1.1 **Transporter must submit have experience in transportation of similar job and on behalf of Government organisations/ PSUs etc. within the last 3 years.**
- 1.2 Bid document should be type written. The Transporter should sign and stamp on each page of the bid document. Overwriting should be avoided.
- 1.3 Any information furnished by the Transporter applicant found to be incorrect would render him to be debarred from tendering or taking up any work with BBJ.

**1.4 Earnest Money Deposit:**

Deposit of Earnest Money amounting to Rs.5000/- (Rupees Five Thousand only) may be made in the form of Pay Order/ Demand Draft drawn in favour of "The Braithwaite Burn And Jessop Construction Company Ltd.", payable at Kolkata and shall be valid for a period of 90 (ninety days) from the date of opening of the tender. In case the bidder withdraws their offer within validity period of their offer or fails to undertake the work after acceptance of their tender, the full amount of EMD shall be forfeited. Tender(s) submitted without EMD or with less deposit of EMD than specified in the Techno-Commercial bid shall be rejected.

EMD will be converted to Security Deposit and will be kept till completion of Defect Liability Period for the successful bidder. For unsuccessful bidder, EMD shall be refunded immediately after finalization of the tender. EMD shall be interest free.

**2.0 SCOPE OF WORK:**

1. **Portal Cabin (02 Nos) – SIZE – 20 FT X 10 FT X 10 FT**
  2. **12 MT Capacity Hydra Crane (02 Nos) – Length – 7.1 Meter, Width – 2.25 Meter, Height – 3.2 Meter**

  - b) **BIDDERS ARE REQUESTED TO QUOTE PRICE AS PER TRIP BASIS.**
  - c) **Minimum tonnage clause is not applicable, unless & otherwise instructed in writing.**

- d) Payment will be made by per Trip Basis.
- e) Any deviation of the above quotation will be treated as cancelled.
- f) Loading & unloading will be done by Site.
- g) **Any incidental charges for transportation on road to be borne by the party. Detention charges will not be paid for delay of loading at our site.**
- h) **Appropriate vehicle for lifting Portal Cabin and Hydra Crane to be placed as soon as intimated by BBJ.**
- i) Each vehicle should be provided with appropriate communication system for monitoring movement.
- j) The transporter should visit the both point (loading & unloading) to see the road conditions and the materials before quoting their rates. As the materials are not standard shape & size. Bidder must visit site at Kharsia Site to see the materials before bidding.
- k) **Penalty: In case of delayed placement of vehicle for lifting of materials at loading point beyond 48 hours of notification of the same by BBJ through phone/ sms/ email/ fax/ letter (anyone or multimode) or delay beyond the agreed transit period penalty at the rate of Rs.100 per MT per day will be deducted from the bills.**
- l) **Immediate commencement with 48 hrs notice for deploying vehicle.**
- m) Road Permit will be arranged by BBJ.
- n) Rate should be quoted per trip basis. **The rate should be inclusive of all but exclusive of GST as per Rule.**
- o) **Loading time – 48 Hours.**

**3. PAYMENT TERMS:**

Within 30 days from the date of delivery of the materials with proper document at project site.

**4. TRANSIT PERIOD:**

To be mentioned clearly for only transportation of each trip by Trailer & Truck.

**5. TIME PERIOD:**

**12 (Twelve)** months from the date of LOI/Work order.

**6. LIQUIDATED DAMAGE:**

If the Transporter fails to complete the job within stipulated transit period, 0.5% of order value will be deducted from bill for per week delay subject to a maximum of 5% of the total order value.

**7. TERMINATION OF CONTRACT:**

In case of failure to discharge the duties as per our requirement, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency /agencies. Cost incurred for the above shall be recovered from the contractor's bill and Security Deposit.

**SPECIAL CONDITION OF CONTRACT****SCC-3****8. TIME EXTENSION:**

If the Transportation part or full quantity is delayed due to reasons not attributable to the transporter, extension of time without L. D. may be permitted as per the discretion of BBJ. However, for such extension the transporter has to apply with valid and authentic reasons prior to expiry of delivery time. However, if the delay in transportation is attributable to the transporter L.D. clause as per CL. NO. 6 will be implemented.

9. BBJ reserves the right to award different BOQ items (s) on different parties. Work in hand of bidders will be considered while placing the order.

**11. SUBMISSION OF INVOICE:**

**The invoice raised by the transporter for the transport carried out in a particular month should reach BBJ-Head Office within 5th of the next month** e.g. invoice for transport in Dec-18 must reach BBJ-Head Office, Kolkata by 5<sup>th</sup> Jan-19.

**12. RATE**

The vendors must submit their offer strictly as per Bill of Quantities. **The bidder must quote the Basic Rate including all other taxes & duties (excluding GST, which will be extra as applicable) and delivery charges at site for the items mentioned in BOQ.** The price must be firm during the tenure of this contract and no escalation on any account will be allowed.

**Notes:**

The award of the order or rejection of the Tenderer's offer and/or cancellation of the tender will be made at the absolute discretion of BBJ. BBJ reserves the right to cancel or accept or reject any or all tender(s), whether lowest or otherwise, without assigning any reason(s), whatsoever thereof. A tenderer whose tender is not accepted shall not be entitled to claim any cost, charges or expenses incidental to or incurred by him through or in connection with the preparation and submission of the Tender/Offer to BBJ. BBJ also reserves the absolute right to split up and award the requirement between two or more Tenderers.

**13.0 TAXES & DUTIES:**

The contractor shall be exclusively responsible for payment of all Taxes, Royalties etc. (except Goods and Service Tax) that may be levied from time to time according to the Laws & regulation now in force & also hereafter to be imposed, increased or modified from time to time. Nothing will be payable extra by the Company in respect of any duties/ taxes to be imposed on procurement of materials for execution of contract.

**SPECIAL CONDITION OF CONTRACT****SCC-4****14.0 GOODS AND SERVICE TAX (GST)**

**14.1** Without prejudice to stipulation in General Conditions of Contract, the quoted price shall be exclusive of **Goods and Service Tax**. The GST as legally leviable & payable by the bidder under the provisions of applicable law/act shall be paid extra by BBJ as per bidder's bill. Bidder shall quote their rate after considering the input tax credit on their input materials and services.

The bidder shall get registered with the GST authorities and the registration certificate shall be submitted along the bid documents (techno commercial). Bid without GST number shall be cancelled.

At present GST-TDS is applicable. Deduction of GST-TDS at source would be enforced from the running bills at the rates prescribed. The GST (i.e. SGST, CGST or IGST) amount shall be shown separately in invoice and also submit proper **Tax Invoice as per section 31 of CGST Act, and Rule 46 of CGST Rules, 2017 to get Input Tax Credit by BBJ.**

**Bidder shall raise their tax invoice in regular interval as per contract condition and uploaded their supply invoice in GSTN Portal through GSTR-1 return with 10th of next month. Mismatch in return of BBJ due to any reason attributable to bidder, the same shall be recovered from Bidder's bill.**

**14.2 New Levies/ Taxes**

In case Government imposes any new levy / tax after award of the work during the tenure of the contract, BBJ shall reimburse the same at actual on submission of documentary proof of payment subject to the satisfaction of BBJ that such new levy/tax is applicable to this contract.

**15.0 ARBITRATION**

In the event of any questions arising out of the Contract or ancillary/ incidental as to the terms and conditions of it or relate to any matter for execution and/or performance of the contract, the same shall in-so-facto be referred to the appropriate Authority and the interpretation made by the said authority shall be final and binding upon the parties.

Notwithstanding the above, should there be any, disputes or differences by and between the parties arising out of anything under the contract, the same shall within 30 days of its occurrence first be referred to the said authority for conciliation and/or determination by the said authority. If the findings of the said authority should be acceptable by parties to the contract as communicated in writing within the next following 30 days of making reference to it. Nevertheless, the parties at their sole option shall within the next following 30 days choose to refer or cause the matter to be referred to the Arbitrator of Person in writing, whereupon the appropriate Authority shall within two weeks hence take steps for appointment of Arbitrator of Person from amongst the officers whether or not connected in the matter and the same shall be communicated in writing to the parties making reference within the next following two weeks and the same shall be final and

binding upon the parties. The Arbitrator shall enter into the reference by appropriate notice of communication to be served or cause the said notice to be served upon the parties summoning the respective parties to attend the proceedings at the date time and venue. The proceedings of Arbitration shall be as per the Arbitration and Conciliation Act 1996 as amended up to date. Jurisdiction of the matter shall be within the appropriate Courts of Kolkata. Acceptance of Order/ LOI of the concerned agency shall be deemed to be the Free Consent given by party under the law towards execution of these covenants of contract under the Contract of Arbitration.

**16.0 IMPORTANT NOTES:**

BBJ reserves the right to:

- 16.1** Accept or reject any bid received at its discretion without assigning any reasons whatsoever.
- 16.2** Increase/ decrease/ alter the job description/ scope of work with corresponding change in the value of contract.
- 16.3** Postpone or extend the above-mentioned date, split and distribute the work among more than one Transporter without assigning any reason what so ever.
- 16.4** May ask for further qualification during techno commercial scrutiny of bids received.
- 16.5** BBJ shall not be responsible for any delay, loss, damage for bids sent by post.
- 16.6** BBJ shall not be liable for any expenses incurred by Transporter in preparation of bid irrespective of whether it is accepted or not.
- 16.7** Canvassing i.e. soliciting favour, seeking advantage etc. in any form is strictly prohibited and any Transporter found to have engaged in canvassing shall be liable to have his bid rejected summarily.
- 16.8** If the Transporter deliberately gives any wrong information in his tender to create circumstances for the acceptance to his bid, BBJ reserves the right to reject such application.
- 16.9** All costs and incidental expenses for preparation of the tender, discussion, conference, pre-tender site visit, pre-award discussion with BBJ shall be to the account of the tenderer and BBJ shall bear no liability whatsoever on such cost expenses.
- 16.10** The Tenderer shall submit his price bid/offer in Indian Rupees and payment under this contract will be made in Indian Rupees.
