You are requested to send your sealed quotation for supply of Electrical Rotary Hammer with Drill Bit required at our Ganga Bridge Site,Munger(Bihar) for drilling holes. The description of our required item and other terms & conditions are given hereunder :-

1. **Item required** :-

Notes:- Manufacturer or their authorized dealer(s) is/are entitled to submit their offer. Valid Authorised Dealer should submit the following documents with their offer, otherwise no offer will be considered against the said NIT :-

- (a). Valid authorised dealership certificate. Sub-dealer certificate is not entitled.
- (b). Product Literature/Technical details for the above hammer.
- (c). Copy of VAT Registration Certificate.
- (d). Particular "make"/"brand" is to be mentioned in the offer.

2. **Rate** :- Your quoted rate should be inclusive of all taxes & duties, and delivery charges at our Ganga Bridge Site,Munger(Bihar). Entry Tax will be borne by BBJ.

3. **Validity of Rate** : Your quoted rate should be valid and firm for a period of 3(three) months from the date of opening of your offer.

4. **Excise Duty Gate Pass** :- Necessary Excise Duty Gate Pass(EDGP) to be provided by the manufacturer/supplier for availing MODVAT/CENVAT benefits.

5. **Delivery Period & Delivery Place** :- Delivery to be made at our Ganga Bridge Site, Munger(Bihar) within 30 days from the date of order along with Manufacturer's Test Certificate, Operation, Maintenance Manual and Guarantee & Warranty Certificate in respect of "Electrical Rotary Hammer".
6. **Payment** :- Within 30 days from the date of delivery and submission of bill with receipted challan along with manufacturer's test certificate and guarantee/warranty certificate.
7. **Liquidated Damage** :- If you fail to complete supply as per our order within stipulated period, 0.5% of order value will be deducted from your bill for per week of delay subject to maximum of 5% of order value.
8. **Earnest Money Deposit** :- An amount of **Rs.5,000.00**(Rupees five thousand only) to be submitted with individual offer, as EMD amount in form of account payee Demand Draft/Pay Order/Banker's Cheque in favour of "The Braithwaite Burn And Jessop Construction Company Limited", payable at Kolkata. Unsuccessful bidders will be refunded the Earnest Money Deposit amount after the award of the contract/order to the successful bidder.

The EMD amount of successful bidder will be released within 30 days after completion of total supply/service/installation/work without any interest subject to receipt of written request from the successful bidder.

The Units registered with National Small Industries Corporation(NSIC) are exempted from payment of EMD subject to :

 - (a). The NSIC Registration Certificate till remains valid up to the date of validity quotation
 - (b). The bid is accompanied with a copy of valid NSIC Registration Certificate.
 - (c). Photocopy of application for registration as NSIC for renewal of NSIC will not be acceptable. Such offers will be treated as offers received without EMD.
 - (d). For existing supplier(s), the EMD amount may be adjusted from their passed bill(s) amount, subject to submission of their written declaration with their offer in connection with adjustment of their EMD amount from their outstanding bills if any.
9. **Guarantee** :- Any part of the machine failing or providing unsatisfactory in service due to defective design, material or workmanship within 12 months from the date of supply shall be replaced by the supplier at his own expenses. Should any design modifications be made in any part of the equipment offered, the period of 12 months would commence from the date, the modified part is commissioned in service. The cost of such modification shall be borne by the supplier.
10. **Termination of Contract**:- If the supplier failure to complete the total work/supply/service as per requirement and within the stipulated completion period, BBJ reserves the right to cancel the order, either in part

or full as the situation demands and get the work done by deploying other agency/agencies by issuing first seven days and then 48 hours notice. Additional cost if incurred shall be recovered from the supplier's bill.

11. **JURISDICTION OF COURT:**

The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes,if any,arising out of this agreement between the parties.

12. **Closing Date and Time of Submission** :- Your sealed quotation must reach to our Office on or before **18th January,2016** by **11.30 a.m.**
