<b>02.</b>	<b>LANGUAGE</b> Bids and all accompanying document shall be in English. In case any accompanying documents are in other language, it shall be accompanied by an English translation. The English version shall prevail in matter of interpretation.
<b>03.</b>	<b>SUBMISSION OF TENDER</b>
<b>a)</b>	The Tender shall be signed by the person legally authorised to enter into commitment on behalf of the Tenderer.
<b>b)</b>	All the pages of the tender document to be signed with Company's seal by the Tenderer. The rates in the appropriate space in the <b>BOQ-1</b> should be properly filled, both in figures and words. No overwriting, using of correction fluid will be allowed. Any correction will be done by scoring out the incorrect entry and inserting the new entry in a legible manner. Both the correction and new entry to be signed and sealed with Company's seal. In the event of any difference between figure & words of the quoted rates, the rate in word shall be considered for evaluating the tender.
<b>c)</b>	The tender is to be submitted in a sealed cover and superscribed with Tender Reference, Due Date, marked for the Deputy General Manager(P-V), The Braithwaite Burn And Jessop Construction Company Limited, 27, R. N. Mukherjee Road, Kolkata-700 001 (W.B.).
<b>d)</b>	All costs and incidental expenses for preparation of the tender, discussion, conference, pre-tender site visit, pre-award discussion with BBJ shall be to the account of the tenderer and BBJ shall bear no liability whatsoever on such cost expenses.

**SPECIAL CONDITION OF CONTRACT**

**1. DEFINITIONS AND INTERPRETATION:**

In this Tender Document, as hereinafter defined, the following words and expressions shall have the meaning as under :

- a) "**BBJ**" shall mean The Braithwaite Burn And Jessop Construction Company Limited having its Head Office at 27, R. N. Mukherjee Road, Kolkata - 700 001.
- b) The "**TENDER**" shall mean the proposal submitted by the Tenderer/Bidder in response to BBJ's Notice of Invitation to this Tender Document.
- c) The "**ORDER**" shall mean a written Work Order issued by BBJ.
- d) The "**TRANSPORTER**" shall mean the person, firm or Company (hereinafter called Tenderer) whose Tender has been accepted by BBJ.

**2. SCOPE OF WORK:**

**TRANSPORTATION OF STRUCTURAL STEEL SECTIONS FROM SAIL, ROURKELA STEEL PLANT YARD AND /OR ANY OTHER LOCATION IN ADJOINING AREA WITHIN 30KM RADIUS TO EAST CENTRAL RAILWAY PLANT DEPOT (RAILWAY WAGON WORKSHOP) AT MUGHALSARAI, FOR REPAIRING OF 3400 "C" CATEGORY AND 10500 "B" CATEGORY UNLOADABLE WAGONS AT MGS FOR EAST CENTRAL RAILWAY, MUGHALSARAI.**

- a) Qty. variation -  $\pm 50\%$ .
- b) Service Tax to be paid extra.
- c) VAT/CST/Entry Tax will be borne by BBJ.
- d) Rate should be quoted per MT basis.
- e) **Minimum tonnage clause is not applicable, unless & otherwise instructed in writing.**
- f) Payment will be made as per weighment certificate received by BBJ at Site. Bidder has to satisfy themselves regarding routes and availability of weigh Bridge nearly to site for weighment before entering to site for unloading at site. Otherwise payment will be made on the basis of sectional weight or weighment at loading point, whichever is lower.
- g) Any deviation of the above quotation will be treated as cancelled.
- h) Loading will be done by SAIL, Yards and unloading will be done by BBJ, Site.
- i) **Any incidental charges for lifting at SAIL, Plant/ yard/ warehouse and during transportation on road to be borne by the party. Detention charges will not be paid for delay of loading at SAIL, Plant/ yard/ warehouse & our site.**
- j) **Appropriate vehicle for lifting Section and plates to be placed as soon as intimated by SAIL/ BBJ.**
- k) Each vehicle should be provided with appropriate communication system for monitoring movement.
- l) The transporter should visit the both point (loading & unloading) to see the road conditions and the materials before quoting their rates.
- m) **Security Deposit : EMD amount of successful bidder will be converted in to initial security deposit. Further security deposit will be recovered @10% of the gross value of the bill till the value of this recovered amount together with the EMD reaches 10% of the order value.**
- n) **Penalty : In case of delayed placement of vehicle for lifting of materials at loading point beyond 48 hours of notification of the same by BBJ through phone/ sms/ email/ fax/ letter (anyone or multimode) or delay beyond the agreed transit period penalty at the rate of Rs100 per MT per day will be deducted from the bills.**

**3. FIRM PRICE:**

Your rate shall remain firm and shall not attract escalation due to any reason such as diesel price hike whatsoever in pursuance of this contract for a period of six months from the date of order.

**4. PAYMENT TERMS:**

Within 30 days from the date of delivery of the materials with proper document at project site.

**5. TRANSIT PERIOD :**

To be mentioned clearly for only transportation of each trip by Trailer.

**6. TIME PERIOD :**

Three months from the date of LOI/Work order.

**7. LIQUIDATED DAMAGE:**

If the Transporter fails to complete the job within stipulated transit period, 0.5% of order value will be deducted from bill for per week delay subject to a maximum of 5% of the total order value.

**8. TERMINATION OF CONTRACT:**

In case of failure to discharge the duties as per our requirement, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency /agencies. Cost incurred for the above shall be recovered from the contractor's bill and Security Deposit.

**9. JURISDICTION OF COURT:**

The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.

**10. TIME EXTENSION:**

If the Transportation part or full quantity is delayed due to reasons not attributable to the transporter, extension of time without L. D. may be permitted as per the discretion of BBJ. However, for such extension the transporter has to apply with valid and authentic reasons prior to expiry of delivery time. However, if the delay in transportation is attributable to the transporter L.D. clause as per CL. NO. 7 will be implemented.

**11.** BBJ reserves the right to award different BOQ items (s) on different parties. Work in hand of bidders will be considered while placing the order.

**12.** Bidders must indicate (i) the maximum size and capacity of vehicle based on which quotation is submitted and work will be done (ii) ODC Charges over and above quoted price to be indicated separately.
