01	Registration of Contractor Any contractor willing to take part in the process of e-Tendering will have to been rolled & registered with the Government e-Procurement system, through logging onto https://eprocure.gov.in/eprocure/app
02	Digital Signature certificate(DSC) Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders, from the approved service provider of the National Information's Centre (NIC) on payment of requisite amount details are available at the Web Site stated in Clause 2 of Guideline to bidder DSC is given as a USB e-Token.
03	SUBMISSION OF BID: Bids to be submitted on line through e-Procurement system of Central Public Procurement Portal (CPPP) (https://eprocure.gov.in/eprocure/app) Hard copy of the uploaded/submitted bid shall have to be submitted to this office physically along with the EMD. Tender document to be digitally signed with Company's seal by the bidders. The rates in the appropriate space in the BOQ should be properly filled in. Tenders to be submitted in Single part:
04	" SUBMISSION OF TENDER " shall be read in conjunction with General Commercial Terms and conditions and any other documents forming part of this Tender Document wherever the context so requires. Notwithstanding the sub-division of the documents into the separate section, every part of each shall be deemed to be supplementary to and complementary to every other part.
05	Eligibility Criteria: Bidder must submit with their bid documentary evidence for transportation of structural steel materials from SAIL plants/warehouse/conversion agent for and on behalf of Government organisations/ PSUs etc. within the last 3 years.
06	LANGUAGE Bids and all accompanying document shall be in English. In case any accompanying documents are in other language, it shall be accompanied by an English translation. The English version shall prevail in matter of interpretation.
07	SUBMISSION OF TENDER
a)	The Tender shall be signed by the person legally authorised to enter into commitment on behalf of the Tenderer.
b)	All the pages of the tender document to be signed with Company's seal by the Tenderer. The rates in the appropriate space in the BOQ-1 should be properly filled.
c)	All costs and incidental expenses for preparation of the tender, discussion, conference, pre-tender site visit, pre-award discussion with BBJ shall be to the account of the tenderer and BBJ shall bear no liability whatsoever on such cost expenses.
08	The Bidder must fill the Schedule of Rate (videBOQ-1) with the appropriate column being duly filled in, signed and sealed.
09	Conditional tenders shall be straightway rejected and no additional clause will be entertained.
10	The award of the order or rejection of the Tenderer's offer and/or cancellation of the tender will be made at the absolute discretion of BBJ. BBJ reserves the right to cancel or accept or reject any or all tender(s), whether lowest or otherwise, without assigning any reason(s) whatsoever thereof. A tenderer whose Tender is not accepted shall not be entitled to claim any cost, charges or expenses incidental to or incurred by him through or in connection with the preparation and submission of the Tender/Offer to BBJ. 14	In case of new bidder having no work experience with BBJ in last 5 years becomes successful bidder, one B.G. for Rs.2,00,000.00 (Rupees two lakhs only) to be submitted in favour of The Braithwaite Burn And Jessop Construction Company Limited which will be released after successful completion of the job

SPECIAL CONDITION OF CONTRACT

1. DEFINATIONS AND INTERPRETATION:

In this Tender Document, as hereinafter defined, the following words and expressions shall have the meaning as under:

- a) "**BBJ**" shall mean The Braithwaite Burn And Jessop Construction Company Limited having its Head Office at 27, R. N. Mukherjee Road, Kolkata - 700 001.
- b) The "**TENDER**" shall mean the proposal submitted by the Tenderer/Bidder in response to BBJ's Notice of Invitation to this Tender Document.
- c) The "**ORDER**" shall mean a written Work Order issued by BBJ.
- d) The "**TRANSPORTER**" shall mean the person, firm or Company (hereinafter called Tenderer) whose Tender has been accepted by BBJ.

2. SCOPE OF WORK:

TRANSPORTATION OF STRUCTURAL STEEL PLATES FROM SAIL NAINI WAREHOUSE ALLAHABAD STEEL PLANT AND/OR SAIL BOKARO STEEL PLANT TO OUR RAILWAY WAGON WORKSHOP AT MUGHALSARAI, EAST CENTRAL RAILWAY, PLANT DEPOT, MUGHALSARAI – 232 101

- a) Qty. variation - $\pm 50\%$.
- b) Service Tax to be paid extra.
- c) VAT/CST/Entry Tax/GST will be borne by BBJ.
- d) Rate should be quoted per MT basis.
- e) Payment will be made as per weighment certificate received by BBJ at Site. Bidder has to satisfy themselves regarding routes and availability of weigh Bridge nearby to site for weighment before entering to site for unloading at site. Otherwise payment will be made on the basis of sectional weight or weighment at loading point, whichever is lower.
- f) Any deviation of the above quotation will be treated as cancelled.
- g) Loading will be done by SAIL, Yards and unloading will be done by BBJ, Railway Wagon Workshop at Mughalsarai.
- h) **Any incidental charges for lifting at SAIL, Plant/ yard/ warehouse and during transportation on road to be borne by the party. Detention charges will not be paid for delay of loading at SAIL, Plant/ yard/ warehouse & our site.**
- i) **Appropriate vehicle for lifting Section and plates to be placed as soon as intimated by SAIL/ BBJ.**
- j) Each vehicle should be provided with appropriate communication system for monitoring movement.
- k) The transporter should visit the both point (loading & unloading) to see the road conditions and the materials before quoting their rates.
- l) **Penalty: In case of delayed placement of vehicle for lifting of materials at loading point beyond 48 hours of notification of the same by BBJ through phone/ sms/ email/ fax/ letter (anyone or multimode) or delay beyond the agreed transit period penalty at the rate of Rs.100 per MT per day will be deducted from the bills.**

3. FIRM PRICE:

Your rate shall remain firm and shall not attract escalation due to any reason such as diesel price hike whatsoever in pursuance of this contract for a period of six months from the date of order.

4. PAYMENT TERMS:

Within 30 days from the date of delivery of the materials with proper document at project site.

5. TRANSIT PERIOD:

To be mentioned clearly for only transportation of each trip by Trailer.

6. TIME PERIOD:

06 (six) months from the date of LOI/Work order.

7. LIQUIDATED DAMAGE:

If the Transporter fails to complete the job within stipulated transit period, 0.5% of order value will be deducted from bill for per week delay subject to a maximum of 5% of the total order value.

8. TERMINATION OF CONTRACT:

In case of failure to discharge the duties as per our requirement, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency /agencies. Cost incurred for the above shall be recovered from the contractor's bill and Security Deposit.

9. JURISDICTION OF COURT:

The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.

10. TIME EXTENSION:

If the Transportation part or full quantity is delayed due to reasons not attributable to the transporter, extension of time without L. D. may be permitted as per the discretion of BBJ. However, for such extension the transporter has to apply with valid and authentic reasons prior to expiry of delivery time. However, if the delay in transportation is attributable to the transporter L.D. clause as per CL. NO. 7 will be implemented.

11. BBJ reserves the right to award different BOQ items (s) on different parties. Work in hand of bidders will be considered while placing the order.
