02	<u>DIGITAL SIGNATURE CERTIFICATE (DSC)</u> Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders, from the approved service provider of the National Information's Centre (NIC) on payment of requisite amount details are available at the Web Site stated in Clause 2 of Guideline to bidder DSC is given as a USB e-Token.
03	<u>SUBMISSION OF BID:</u> Bids to be submitted online through e-Procurement system of Central Public Procurement Portal (CPPP) (https://eprocure.gov.in/eprocure). Hardcopy of the uploaded/ submitted bid shall have to be submitted to this office physically along with the EMD. Tender document to be digitally signed with Company's seal by the bidders. The rates in the appropriate space in the BOQ should be properly filled in. Tenders to be submitted in Single part:

SPECIAL CONDITION OF CONTRACT

1. DEFINITIONS AND INTERPRETATION:

In this Tender Document, as hereinafter defined, the following words and expressions shall have the meaning as under

- a) "**BBJ**" shall mean The Braithwaite Burn & Jessop Construction Company Limited having its registered Office at 27, R. N. Mukherjee Road, Kolkata- 700 001.
- b) The "**TENDER**" shall mean the proposal submitted by the Tenderer/ Bidder in response to BBJ's Notice of Invitation to this Tender Document.
- c) The "**ORDER**" shall mean a written Purchase Order issued by BBJ.
- d) The "**TRANSPORTER**" shall mean the person, firm or Company (hereinafter called Tenderer) whose Tender has been accepted by BBJ.

2. SCOPE OF WORK:

- a) Transportation of fabricated Steel Girders from Railway workshop at Sini to our bridge sites (may be anyone at Manoharpur or Jaraikela or Bisra (within 20km radius of Jaraikela) as per **BOQ-1**.
- b) Qty. variation - $\pm 20\%$.
- c) Minimum Tonnage for Trailer 18 MT Capacity and Truck 12 MT Capacity.
- d) Loading and unloading will be done by BBJ.
- e) Detention charge will not be paid for delay of loading.
- f) Any deviation of the above quotation will be treated as cancelled.
- g) Transport to be placed at loading point within 48 hours after BBJ's confirmation.
- h) The transporter should visit the both point (loading & unloading) to see the road conditions and the materials before quoting their rates.
- i) Before submitting the Tender, the Tenderer(s) will get satisfied himself/themselves by actual inspection of routs and road conditions.
- j) Any incidental expenses during transportation will be borne by Transporter and BBJ has no liability in this regard.
- k) No claims for change of route, if it necessitates during transporting of materials shall be entertained.

3. FIRM PRICE:

Your rate shall remain firm and shall not attract escalation due to any reason such as diesel price hike whatsoever in pursuance of this contract for a period of six months from the date of order.

4. PAYMENT TERMS:

Within 30 days from delivery.

5. TRANSIT PERIOD:

To be mentioned clearly for only transportation of each trip.

6. LIQUIDATED DAMAGE:

If the Transporter fails to complete the job within stipulated transit period, 0.5% of order value will be deducted from bill for per week delay subject to a maximum of 5% of the total order value.

7. TERMINATION OF CONTRACT:

In case of failure to discharge the duties as per our requirement, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency /agencies. Cost incurred for the above shall be recovered from the contractor's bill and Security Deposit.

8. JURISDICTION OF COURT:

The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.

9. TOTAL DURATION OF TIME:

The job to be completed by 06 months from the date of LOI /Order.

10. TIME EXTENSION:

If the Transportation part or full quantity is delayed due to reasons not attributable to the transporter, extension of time without L. D. may be permitted as per the discretion of BBJ. However, for such extension the transporter has to apply with valid and authentic reasons prior to expiry of delivery time. However, if the delay in transportation is attributable to the transporter L.D. clause as per CL. NO. 6 will be implemented.

11. TAXES & DUTIES:

Service Tax will be extra, as applicable. However, Entry Tax will be borne by BBJ.
