4. **Delivery Period and Place** :- At BBJ Ganga Bridge Site,Munger(Bihar) alongwith Manufacturer's Test Certificate/Field sampling/Test Report of NABL approved Lab within 30 days from the date of LOI/Order.
5. **Payment** :- Will be made within 30 days after delivery at site based on receipted challan and Manufacturer's Test Certificate/Field sampling/Test Report of NABL approved Lab.

6. **Earnest Money Deposit** :- An amount of **Rs.5,000.00**(Rupees five thousand only) to be submitted with individual offer, as EMD amount in form of account payee Demand Draft/Pay Order/Banker's Cheque in favour of "The Braithwaite Burn And Jessop Construction Company Limited", payable at Kolkata. Unsuccessful bidders will be refunded the Earnest Money Deposit amount after the award of the contract/order to the successful bidder.

(d). For existing supplier(s), the EMD amount may be adjusted from their passed bill(s) amount subject to submission of their written declaration with their offer in connection with adjustment of their EMD amount.
7. **Termination of Contract**:- If the supplier/party failure to complete the total work/supply/service as per requirement and within the stipulated completion period, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency/agencies by issuing first seven days and then 48 hours notice. Additional cost if incurred shall be recovered from the supplier's bill.
