BBJ also reserves the absolute right to split up and award the requirement between two or more Tenderers.
2. **Rate** :- Your quoted rate should be inclusive of all taxes and duties and delivery charges. Particular "**make/brand**" is to be mentioned in the offer, otherwise no offer will be considered against the said NIT. Entry Tax, if any, will be borne by BBJ.
3. **Validity of Rate** : Your quoted rate should be valid and firm for a period of 3(three) months from the date of opening of your offer.
4. **Delivery at** :- BBJ Heavy Plant Yard, P-82 Taratala Road,Garden Reach,Kolkata-700 024.
5. **Delivery Period**: - Within 30 days from the date of LOI/ORDER, whichever is earlier.
6. **Payment** :- Within 30 days from the date of delivery and submission of bill with receipted challan.
7. **Earnest Money Deposit** :- An amount of **Rs.5,000.00**(Rupees five thousand only) to be submitted with individual offer, as EMD amount in form of account payee Demand Draft/Pay Order/Banker's Cheque in favour of "The Braithwaite Burn And Jessop Construction Company Limited",
