2. **Rate** :- Your quoted rate should be inclusive of all taxes and duties and delivery charges up to our Heavy Plant Yard,Kolkata.
3. **Validity of Rate** : Your quoted rate should be valid and firm for a period of **3(three) months** from the date of opening of tender.
4. **Delivery at** :- BBJ Heavy Plant Yard, P-82 Taratala Road,Garden Reach,Kolkata-700 024.
5. **Delivery Period**: - Within **30 days** from the date of LOI/ORDER whichever is earlier.
6. **Payment** :- Within 30 days from the date of delivery and submission of bill with receipted challan.
7. **Earnest Money Deposit** :- An amount of **Rs.5,000.00**(Rupees five thousand only) to be submitted with individual offer, **as EMD amount** in form of account payee **Demand Draft/Pay Order/Banker's Cheque** in favour of "**The Braithwaite Burn And Jessop Construction Company Limited**", payable at Kolkata. 8. **Liquidated Damage** :- If you fail to complete total supply as per our order within stipulated period, 0.5% of order value will be deducted from your bill for per week of delay subject to maximum of 5% of order value.
9. **Termination of Contract**:- If the supplier failure to complete the total work/supply/service as per requirement and within the stipulated completion period, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency/agencies by issuing first seven days and then 48 hours notice. Additional cost if incurred shall be recovered from the supplier's bill.
