### **TERMS & CONDITIONS:**

1. The bidder must be **RDSO approved** for supply of the above items and must attach **documentary evidence** showing that they are enlisted in the RDSO "**LIST OF APPROVED VENDOR**".
2. The bidder should mention their brand name against each item as per specification.
3. **Manufacturer's Test Certificate** must be enclosed along with each consignment indicating shelf life/expiry date of the items given above.

### **4. Delivery schedule :**

- a) Within **30 (thirty) days from the date of LOI/Order which ever is earlier.**
- b) If necessary, Phase-wise delivery must be made at our Ganga Bridge Site, Munger (Bihar) on intimation by BBUNL/BBJ from time to time.

### **5. RATE :**

a) The vendors must submit their offer **strictly as per Bill of Quantities BOQ-1** of this tender document. The bidder must quote **the Basic price, Excise Duty, all other taxes & duties and delivery charges** (at Ganga Bridge Site, Munger, Bihar) **Per unit item** as per BOQ-1. The **price must be firm** during the tenure of this supply contract & **no escalation on any account will be allowed. Entry Tax will be borne by BBUNL/BBJ.**
