**3.0** Interested firms/ contractor shall have to submit necessary documents in support of complying the following eligibility criteria along with their application of Expression of Interest for aforesaid work.

**(a) Eligibility Criteria:**

**(i) Technical Eligibility Criteria:**

The firms/contractor should have completed at least one similar single work for a minimum value of **35%** (thirty-five percent) of advertised tender value for all components including Substructure work i.e. **Rs.63,25,64,272.54**

Similar nature of works physically completed within the qualifying period, i.e. the last 3 financial years and current financial year up to the date of opening of the tender under Government/ Semi Government (even though the work might have commenced before the qualifying period) should only be considered in evaluating the eligibility criteria.

**Similar nature of work means "CONSTRUCTION OF MAJOR BRIDGES INVOLVING WELL FOUNDATION INCLUDING AT LEAST 1(ONE) WELL BY CAISSON FLOATING METHOD".**

Note: For JV purpose: The tendered work is a composite work with component of superstructure shall be Rs.58,54,05,326.00 and all components including substructure component shall be Rs.63,25,64,272.54. The members satisfying technically eligibility criteria for the largest component (Sub structure in this case) of the work shall be the lead member and that member shall have a majority (at least 51%) share of interest in JV firm as per the instruction of JV firm vide clause No.20 of Chapter-I of "Salient Features of Tender".

**(ii) Financial Eligibility Criteria:**

The firms/ contractor shall be eligible only if they will fulfill the Minimum Eligibility Criteria of having received total contract amount during the last three financial years and in the current financial year with a minimum of **150%** (one hundred fifty percent) of the advertised tender value for all components including Substructure work i.e. **Rs.63,25,64,272.54**.

Authentic Certificates shall be produced by the tenderer(s) to this effect which may be an attested Certificate from the employer/ client, Audited Balance Sheet duly certified by the Chartered Accountant etc.

Note: Certificate from private individuals/ firms for whom such works are executed/ being executed shall not be considered.

All other terms & conditions of the above mentioned in EOI will remain unchanged.
